Project:

Repairs to Gas Line Settlement on CR-517 & CR-669

Locations are as follows:

- CR-517 (Decker Pond / Tranquility Road) from CR-603 (Airport Road) in Green Township to the Railroad Tunnel in Andover Borough
- CR-669 (Limecrest Road) from SR-206 to CR-616 Intersection in Andover Township

Contractor:

Atlantic Infra, Inc. in conjunction with Skoda Contracting Company, Inc. on behalf of Elizabethtown Gas Company. Note this work is being performed under a Sussex County Road Opening Permit for work within the County Right of Way (ROW)

Project Funding:

Private Funding.

Anticipated Schedule:

- Construction Start Monday, May 29, 2017
- Anticipated Completion Friday, June 2, 2017

(Schedule subject to change based on unforeseen impacts.)

Traffic Impacts:

Construction will require mobile, single lane closures with alternating traffic during daytime hours. Delays expected.

Construction Activities:

- Excavation and removal of materials to the depth of 18" in predetermined areas. (Completed Fall of 2016)
- Place 11" of soil cement in excavated area (Completed Fall of 2016)
- Place 7" base pavement to surface. (Completed Fall of 2016)
- Mill and Pave 2" x variable width along all predetermined settlement areas.
- Restripe in areas disturbed by milling and paving.

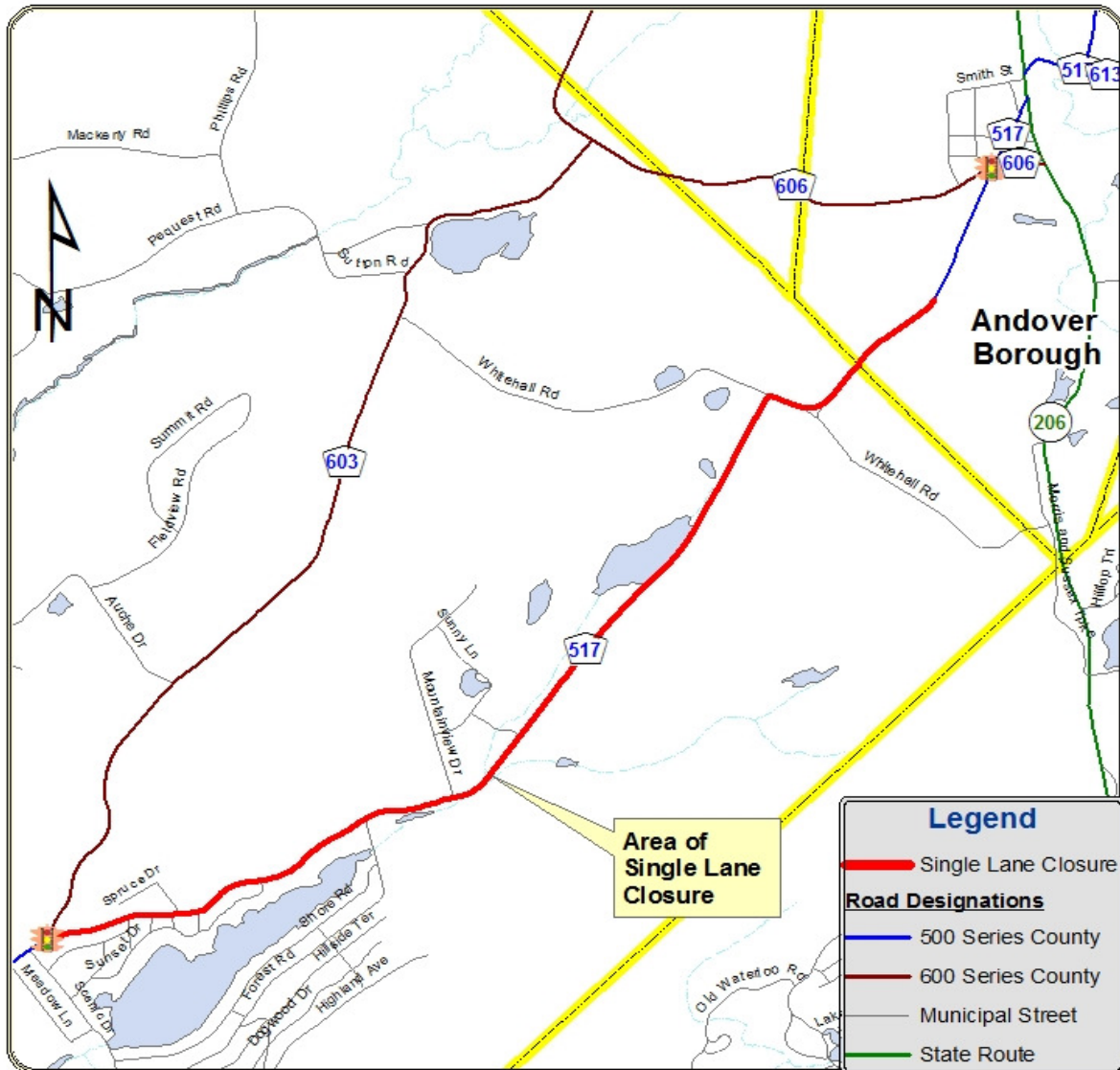

Map: CR-517 – Mobile, Single Lane Road Closure

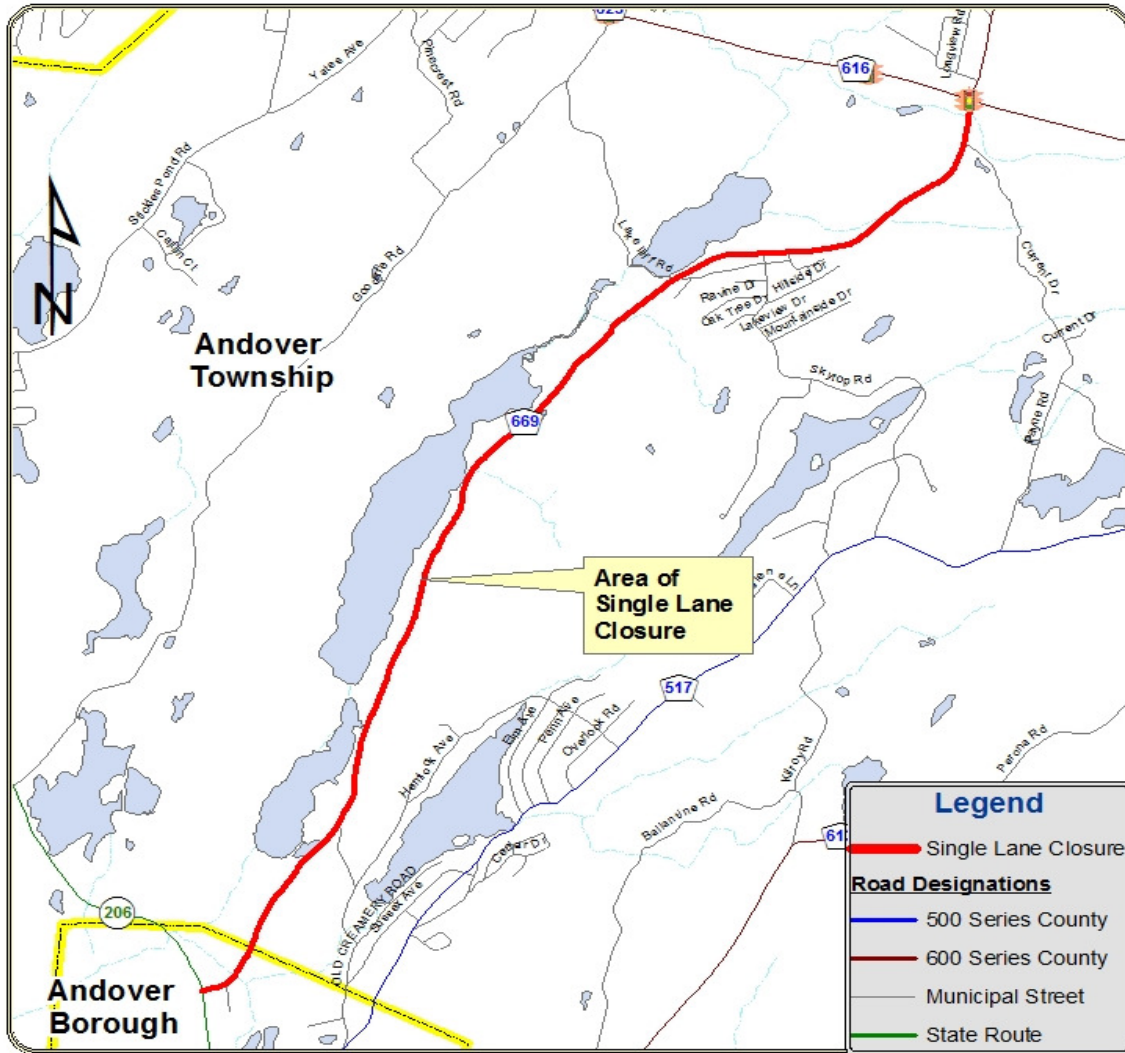
