

### Map changes for Future Sewer Area Map since June 2013:

- a. Hampshire Co., portion of Lots 36.01 and 36.02 in Block 2, **Wantage** – shown as SCMUA sewer area, based on Preliminary Approval in Freeholder Resolution dated August 15, 2012, supporting Resolutions from Wantage Twp. Committee and SCMUA
- b. Wantage Plaza (owned by Main Land Sussex), portion of Lots 12 and 13.02 in Block 7, **Wantage** – shown as SCMUA sewer area, based on Preliminary Approval in Freeholder Resolution dated June 11, 2014, supporting Res. from Wantage and SCMUA
- c. Bicsak Bros., at Blair Road, portion of Lot 5 Block 11 and Lot 1.01 Block 10, Rt. 23, **Wantage** –shown as SCMUA sewer area based on Preliminary Approval in Freeholder Resolution dated June 11, 2014, supporting Res. from Wantage and SCMUA
- d. Removal of sewer service area for Sussex Properties, **Andover Borough** since it was preserved as Open Space
- e. Changed ‘Big N Shopping Center’ area, **Hampton** --to be served by Martin property (Map #59), based on Preliminary Approval in Freeholder Resolution dated November 7, 2007 and subject to agreement by facilities’ owners
- f. McKeown School area in **Hampton Twp.** is served by Kittatinny Regional H.S. plant
- g. Removal of sewer service area for “TMB Partners”, Rt. 15 **Lafayette** [Quick Chek was built there]
- h. Removed lots from sewer area on Maione property (Map #77) on Rt. 23, **Wantage** based on DEP letter dated December 2012. Sewer area now consists of Block 4 Lot 1.05; Block 4.01 Lot 5; and Block 4.02 Lots 1 and 2 (NJPDS Permit # NJ0227536)
- i. Removed “D” discharge locations from the map for Crest Aggregates (in **Lafayette, and Sparta**), it is not a sanitary sewer discharge
- j. Removed “Sparta Sand and Gravel”, **Sparta** from map and List of Facilities, it is a Stormwater permit for vehicle wash water, not for wastewater
- k. Added “Wawa” to list of Facilities for Discharge to GW as #110 NJPDES Permit NJ0166553, portion of Block 158 Lot 6, Rt. 206, **Andover Twp.**
- l. At bottom of map, added Note :  
“The FWSA mapping for **Hopatcong Borough** will be completed separately as part of the Highlands Conforming Municipal Chapter with the Highlands Council.”
- m. On list of DSW Facilities, changed “Schering Corp.” to “Commercial Property”, **Lafayette.**
- n. Added existing NJPDES Permits that weren’t shown on map, such as for Wawayanda State Park, **Vernon**
