# **USDA Designates Bergen, Passaic, and Sussex Counties as Contiguous Natural Disaster Areas**

Emergency Support to Producers in Surrounding Counties/Border States Also Available

WASHINGTON, March 26, 2019 — Agriculture Secretary Sonny Perdue designated 20 New York counties as primary natural disaster areas. Producers who suffered losses caused by excessive precipitation that occurred on or after July 23, 2018, may be eligible for U.S. Department of Agriculture (USDA) Farm Service Agency (FSA) emergency loans.

The counties in the primary damaged area include Albany, Cattaraugus, Chemung, Chenango, Columbia, Delaware, Fulton, Greene, Hamilton, Jefferson, Lewis, Montgomery, Orange, Otsego, Rockland, Schenectady, Schoharie, Steuben, Sullivan, and Tioga.

This natural disaster designation allows FSA to extend much-needed emergency credit to producers recovering from natural disasters. Emergency loans can be used to meet various recovery needs including the replacement of essential items such as equipment or livestock, reorganization of a farming operation or the refinance of certain debts.

Producers in the contiguous New York counties of Allegany, Broome, Chautauqua, Cortland, Dutchess, Erie, Essex, Franklin, Herkimer, Livingston, Madison, Oneida, Ontario, Oswego, Putnam, Rensselaer, St. Lawrence, Saratoga, Schuyler, Tompkins, Ulster, Warren, Westchester, Wyoming, and Yates, along with Berkshire County in Massachusetts; Bergen, Passaic, and Sussex counties in New Jersey; and Bradford, McKean, Pike, Potter, Susquehanna, Tioga, Warren, and Wayne counties in

attending.

Pennsylvania, are also eligible to apply for emergency loans.

The deadline to apply for these emergency loans is December 10, 2019.

FSA will review the loans based on the extent of losses, security available and repayment ability.

FSA has a variety of additional programs to help farmers recover from the impacts of this disaster. FSA programs that do not require a disaster declaration include: <a href="Emergency Assistance for Livestock"><u>Emergency Assistance for Livestock</u></a>, <a href="Honeybees and Farm-Raised Fish Program"><u>Honeybees and Farm-Raised Fish Program</u></a>; <a href="Livestock Forage Disaster Program"><u>Livestock Indemnity Program</u></a>; <a href="Operating and Farm Ownership Loans">Operating and Farm Ownership Loans</a>; and the <a href="Tree Assistance Program"><u>Tree Assistance Program</u></a>.
