WHEREAS, public bids were advertised for Ice Control Materials (Rock Salt and Snow Grit) for the County of Sussex, Division of Public Works on June 22, 2021 and publicly received by the Sussex County Bid Proposal Committee on July 13, 2021; and

WHEREAS, the bids received were reviewed by the Division of Public Works, Department of Engineering and Planning and the Purchasing Agent and awarded to the lowest bidder; and

WHEREAS, the low bidder for rock salt is refusing to extend its bid prices beyond May 31, 2022 to members of the County Cooperative Contracts Purchasing System; and

WHEREAS, Atlantic Salt, Inc. was the second-lowest bidder for the provision of Rock Salt and is willing and to extend its bid prices to members of the County Cooperative Contracts Purchasing System through August 10, 2023; and

WHEREAS, it was recommended by the County of Sussex that an award of a contract be made for the provision of rock salt to be extended to members of the County Cooperative Contracts Purchasing System with all work based on the services and rates specified within Atlantic Salt, Inc.'s proposal.
