#### SUSSEX COUNTY HOMESTEAD RECEIVES ACHIEVEMENT AWARD

The Sussex County Homestead was recognized for their achievements during a recent awards Healthcare Ouality ceremony hosted by Strategies, Inc. (HQSI), the Medicare-designated Quality Improvement Organization (QIO) for New Jersey. The award honored the successes the Homestead made as a voluntary participant of the nationwide Nursing Home Quality Initiative (NHQI), a three-year project sponsored by the Centers for Medicare & Medicaid Services (CMS), an agency of the U.S. Department of Health and Human Services. Jake Lighten, Homestead Administrator said, "Our goal is to extend these successes to additional clinical areas."

Long known in the County for long-term care for seniors, the Homestead recently added sub acute services and is in the process of adding new rehabilitation services, including a Balance Stephen Gruchacz, Administrator of Center. Human Services said, "We are proud of the leadership at the Homestead and the staff who care for our residents each day. It is through participation in national initiatives such as this and adding new programs that meet the needs of Sussex County residents that citizens may remain in Sussex County and not travel to other parts of the state for the care they need. It is definitely a quality of life issue for not only the residents who live at the Homestead but also their families."

### **RESIDENTS ELIGIBLE FOR ECONOMIC STIMULUS REBATE**

Even if our residents' incomes are too low to require them to pay taxes, residents must file an income tax return to receive the economic stimulus payment authorized under recently enacted legislation. The payment will be \$300 for individuals or \$600 for married couples filing jointly.

Residents need to file their return by October 15. The Homestead has volunteers to assist residents in filing for the rebate. See the business office for more information on tax returns for rebates.
